When reflecting on 2022, two words reverberating in our minds are growth and change. As the world continued to settle into a new normal, the demand for assistance with basic needs appeared to rise. With the rising prices of food, housing, and overall cost of living, more people have found themselves seeking the assistance of local pantries and other resources to help make ends meet. Our pantry and soup kitchen saw an increase in neighbors that had never visited Westminster before, and for the first time, our afterschool program had a waitlist of students hoping to join.

At the end of 2022, we also said goodbye to Ann Kitchen as our Board Chair. During Ann's time as Board Chair, Westminster expanded our boundaries to serve more neighbors, grew our Christmas Basket program to serve 350 families, and implemented numerous administrative strategies with the Board of Directors and committees. We want to thank Ann for her dedication to supporting Westminster in fulfilling our mission on the Near Eastside.

As we move into 2023, we introduce a new Board Chair, Becky Doemland. We're excited about her extensive knowledge from working with various non-profits and corporations. We are excited about the energy she will bring to the Near Eastside neighbors.

Thanks to your generosity and support, Westminster could continue providing access to basic needs to our neighbors on the Near Eastside. Westminster served over 1,400 more neighbors in our food pantry from 2021 and over 2,000 more meals in our kid's program.

Without our volunteers, donors, sponsors, and partners, we couldn't do what we do. No matter which category you fall under, each of you helps us continue our mission to provide basic needs to our neighbors on the Near Eastside of Indianapolis. 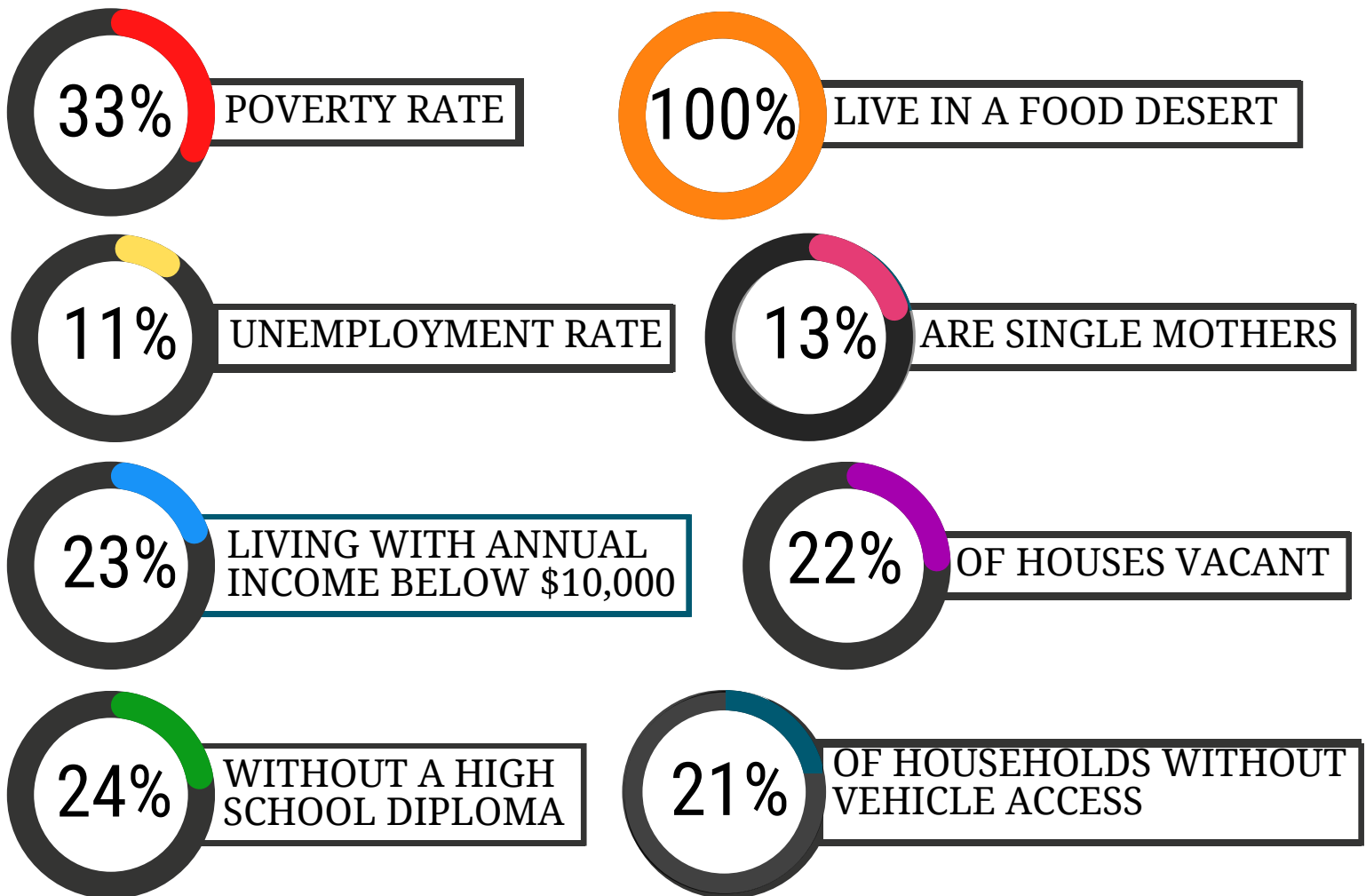

Self Discovery

R has been attending Westminster's afterschool program for two years. In those two years R's progression has been incredible.

When R first started at the afterschool program, it felt like the afterschool staff would often have to make phone calls to Mom due to behavioral issues and R was constantly instigating fights with his brother.

In the past two years R has become much more in tune with his emotions and is able to self-regulate much better than before.

"Just recently, he asked me if I had an more "calming gum" to help him chillout; he's is actively seeking ways to self-soothe and stay in control of his emotions," Ms. Olivia said.

Westminster received a grant that allowed a Ms. Cristina, a licensed therapist, to come in and work with the Westminster kids. Ms.Cristina has played a vast role in helping many of our kids improve their emotional wellness and have a safe space to talk, share, and grow.

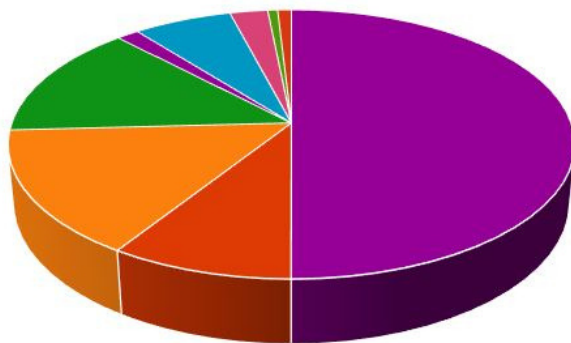

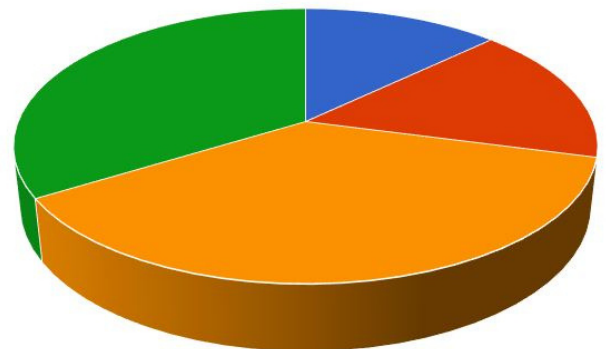

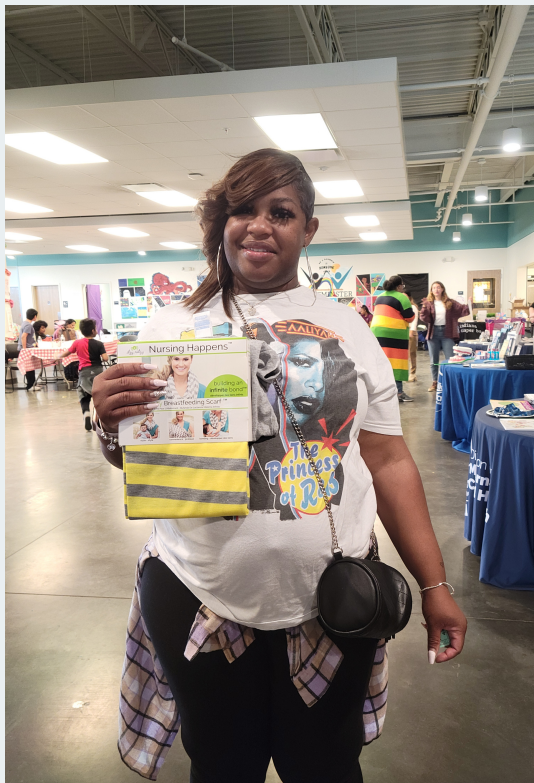
